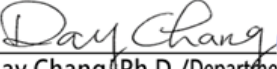

PFAS Remark :

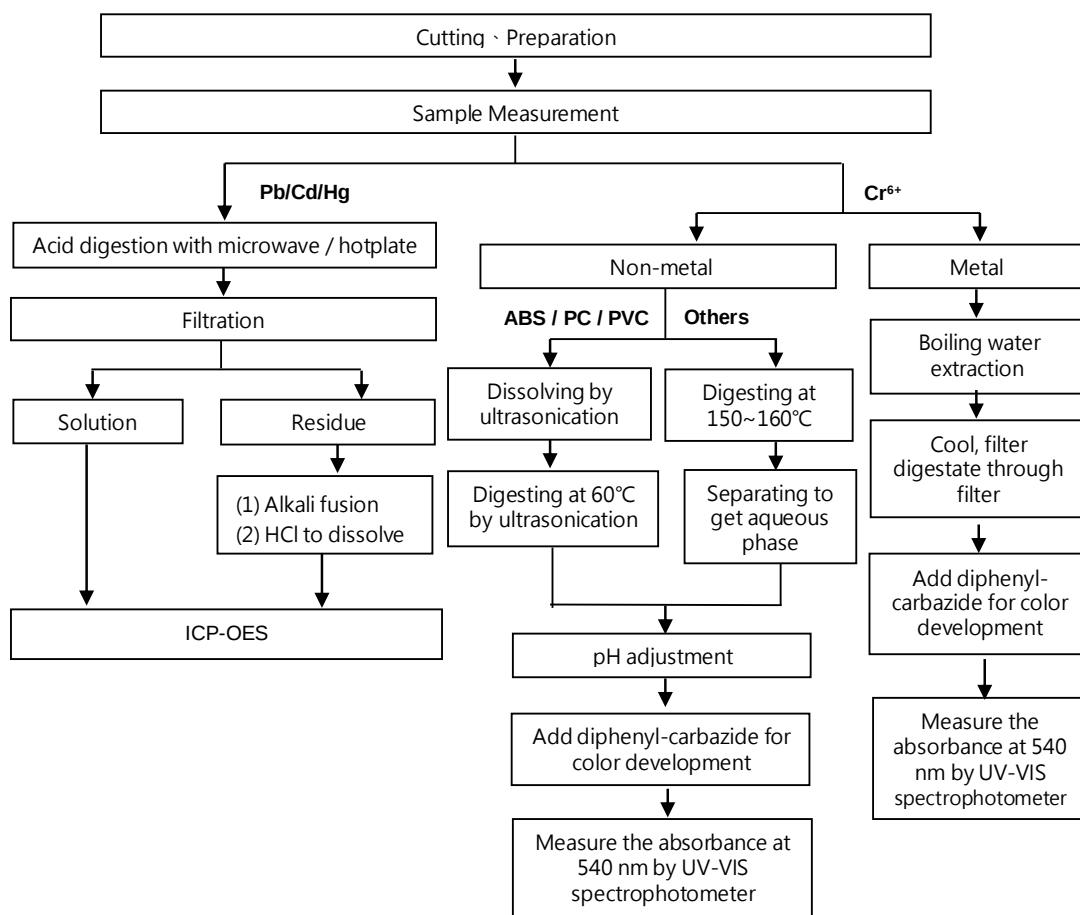

Analytical flow chart of Heavy Metal

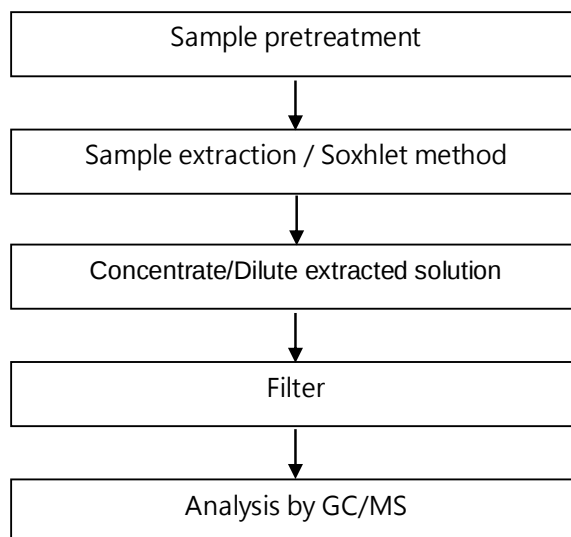

PBB/PBDE analytical FLOW CHART

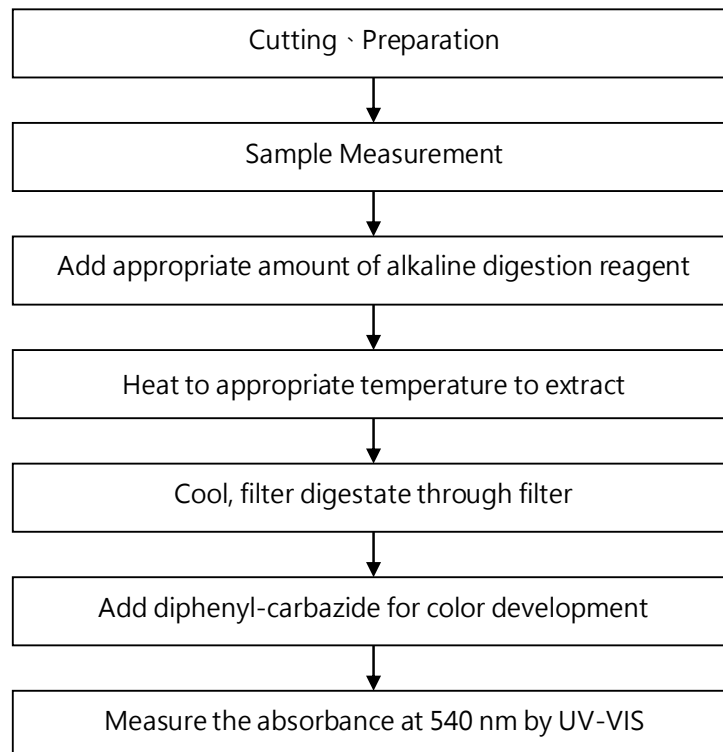

Analytical flow chart - Hexavalent Chromium Cr(VI)

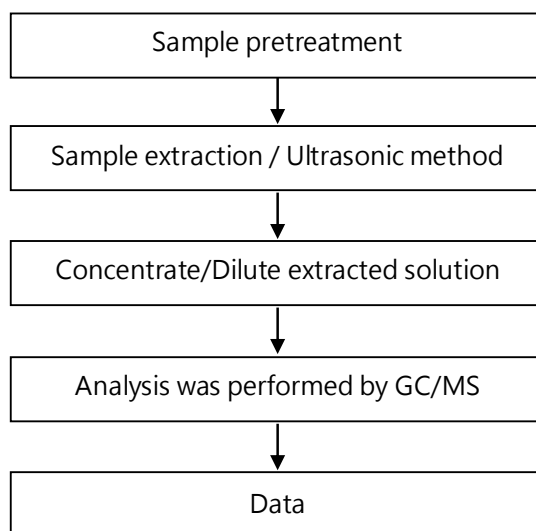

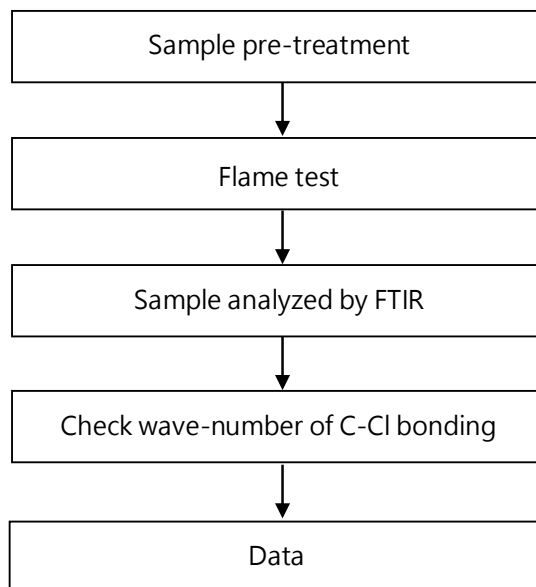
Analytical flow chart of Dimethyl Fumarate

Analysis flow chart - PVC



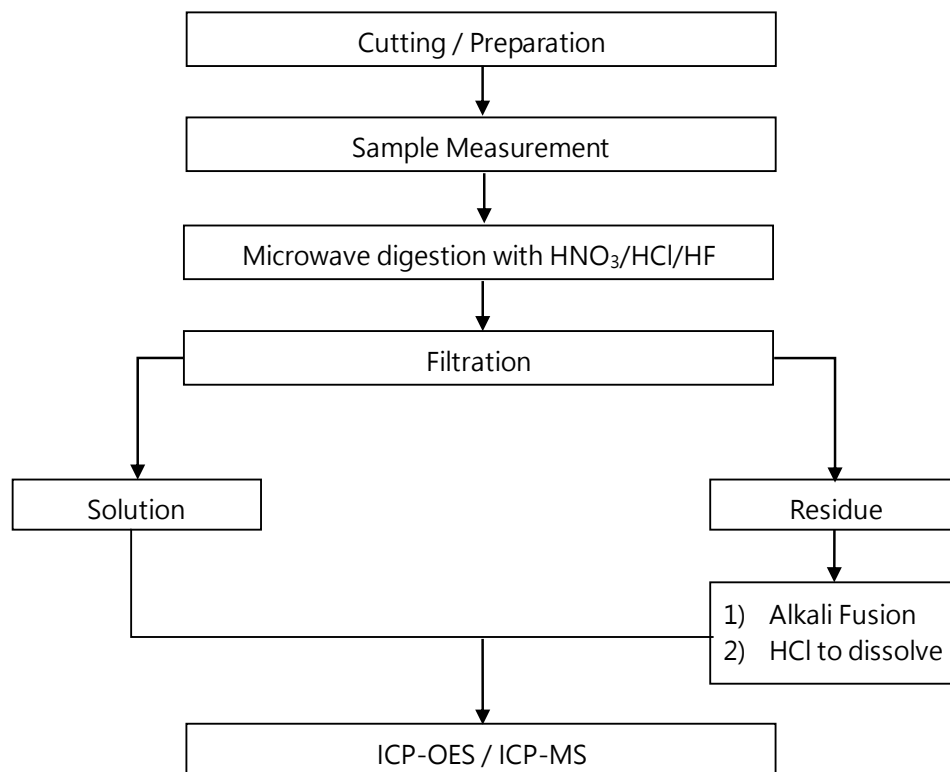

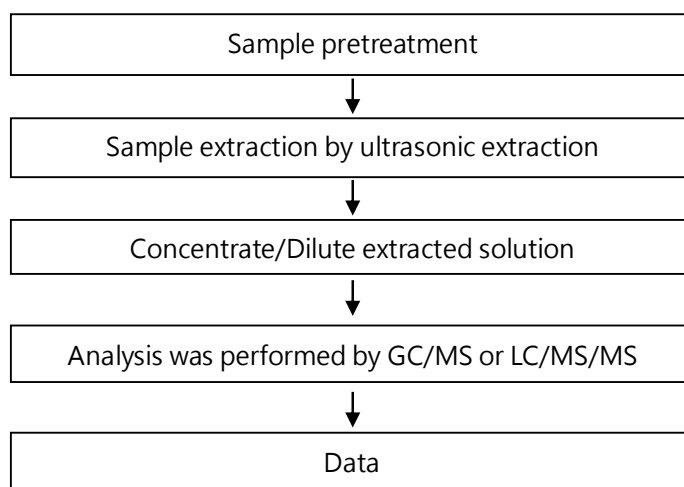

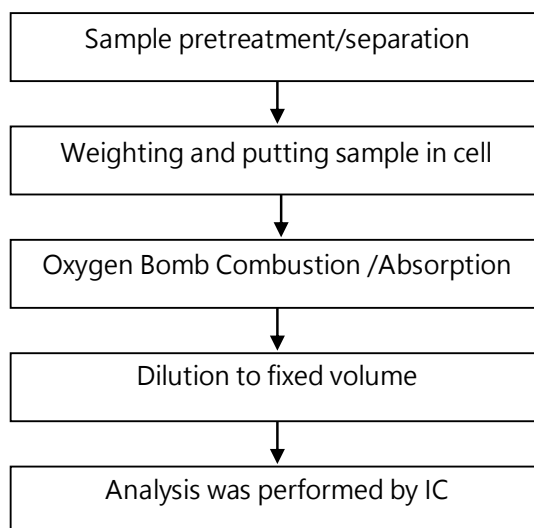

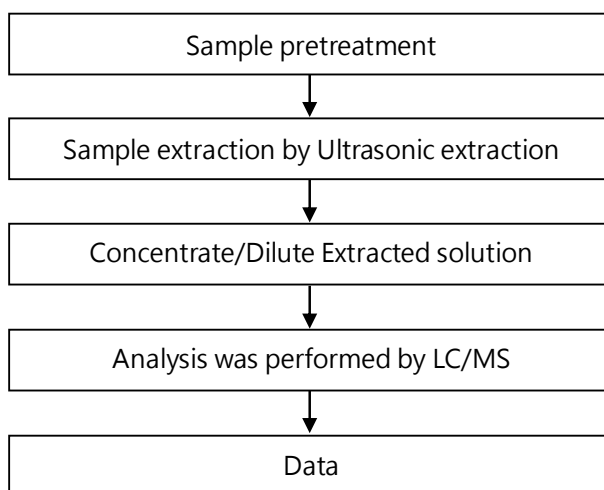
Analytical flow chart of Halogen

TBBP-A analytical flow chart

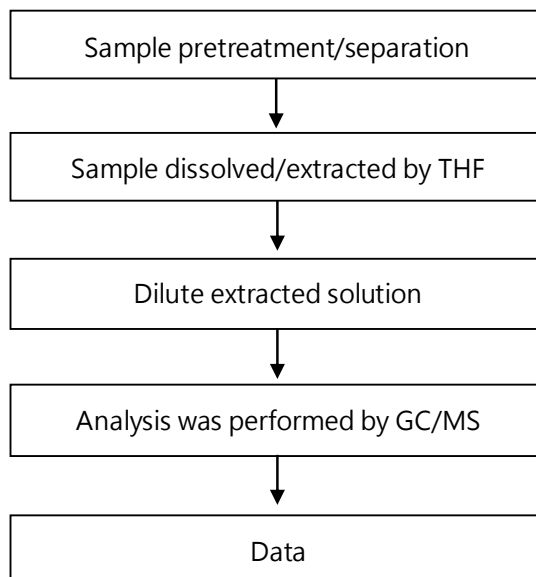

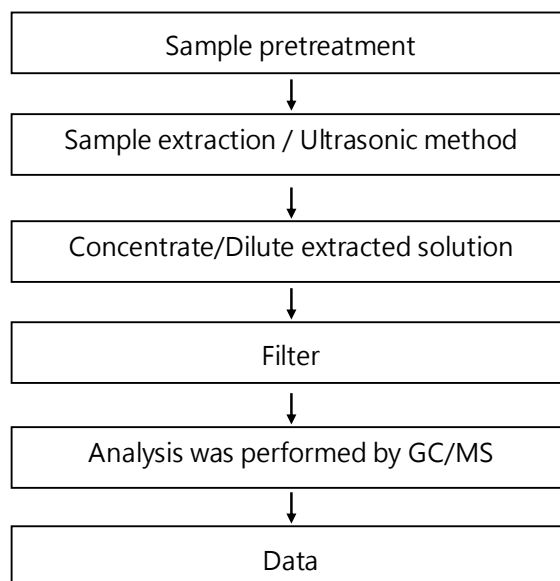

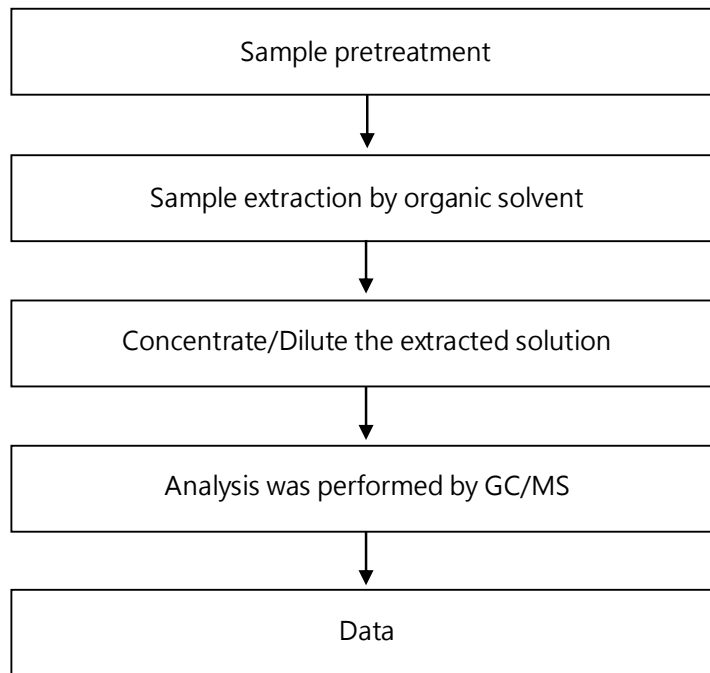
